

**RESOLUTION NO. 2007 - 078**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA ESTABLISHING A BULK TRASH PICK UP ZONE AND PICK UP SCHEDULE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, On July 12, 2007, the Town adopted Ordinance 2007-06, which authorizes the Town Council to establish a bulk pick up schedule by Resolution; and

**WHEREAS**, part of the Town's agreement with Waste Management, Inc., also provides for a specified bulk pick up schedule; and

**WHEREAS**, this Resolution serves to satisfy the requirements of Ordinance No. 2007-06 and the Town's agreement with Waste Management, Inc., by establishing a bulk trash pick up schedule; and

**WHEREAS**, in order to ensure the routine pick up of bulk trash items, the Town Council believes that it is in the best interest of the health, safety, and welfare of its residents to establish a bulk trash pick up schedule.

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Southwest Ranches, Florida:

**Section 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

**Section 2.** The Town Council, in order to ensure the routine pick up of bulk trash items, the Town shall be divided into bulk trash pick up zones. These zones and the days bulk trash shall be picked up within these zones shall be set as follows:

<u>Zone</u>	<u>Pick Up Day</u>
Zone 1: East of I-75 and North of Stirling Road and only South side of Stirling Road	Monday
Zone 2: West of I-75 and East of SW 172 <sup>nd</sup> Avenue	Tuesday
Zone 3: West of I-75 and East of SW 193 <sup>rd</sup> Lane and West of SW 185 <sup>th</sup> Way and SW 186 <sup>th</sup> Avenue	Wednesday
Zone 4: East of I-75 and South of Stirling Road	Thursday

Zone 5: West of I-75 and East of SW 185<sup>th</sup> Way and SW 186<sup>th</sup> Avenue and  
West of SW 172<sup>nd</sup> Avenue  
Zone 6: West of I-75 and West SW 193<sup>rd</sup> Lane


**Section 3. Conflicts.** All Resolutions or parts of Resolutions in conflict herewith, be and the same are hereby repealed to the extent of such conflict.

**Section 4. Severability.** If any portion of this Resolution is determined by any Court to be invalid, the invalid portion shall be stricken, and such striking shall not affect the validity of the remainder of this Resolution. If any Court determines that this Resolution, or any portion hereof, cannot be legally applied to any individual(s), group(s), entity(ies), property(ies), or circumstance(s), such determination shall not affect the applicability hereof to any other individual, group, entity, property or circumstance.

**Section 5. Effective Date.** This Resolution shall be effective immediately upon its adoption.
