

**NOTICE OF MUNICIPAL ELECTION  
TOWN OF SOUTHWEST RANCHES, FLORIDA  
NOVEMBER 5, 2024**

Notice is hereby given that the Town of Southwest Ranches will hold an election on Tuesday, November 5, 2024, for the purpose of electing the Mayor, Council Member District 3 and Council Member District 4. All qualified electors residing in the Town shall be entitled to and permitted to vote in such election. The polls will be open from 7:00 a.m. until 7:00 p.m. Please refer to your voter registration card to determine your voting precinct and polling location. Florida law requires voters to show identification with your picture and signature or you will be required to complete an affirmation in order to vote. The election ballot will be substantially in the following format:
