WHEREAS, On March 6, 2024 Officer Jose Nunez observed a vehicle making an illegal U-turn at 6700 Dykes Road; and

WHEREAS, During his investigation, Officer Nunez discovered the driver had an active warrant for weapons possession out of Puerto Rico and was in possession of a handgun with an extended 30 round magazine; and

Background

Senate Bill 1822 and House Bill 565 provides for the definition of auxiliary containers to be reusable or single-use bags, cups, bottles, cans, or other packaging that meet certain requirements such as the material of which they are made and the use of said containers. Senate Bill 1822 and House Bill 565 further provides that regulation of auxiliary containers is expressly preempted by the State.

Such a state preemption prohibits local governmental agencies and state governmental agencies from enacting any rule, regulation, or ordinance regarding the use, disposition, sale, prohibition, restriction, or tax of auxiliary containers, as well as making any current local governmental agency or state governmental agency rules and regulations unlawful.

The Town, and other municipalities throughout the State of Florida, have repeatedly fought to

protect local government's home rule power against intrusions by the State and the Town Council of the Town of Southwest believes that local government is the closest and most accessible and most responsive to residents; hence the Constitutionally established protected home rule powers should be respected and intrusion in municipal home rule should be strongly discouraged.

The Town Council of the Town of Southwest Ranches believes that such a State preemption on the regulation of recyclable and single-use auxiliary containers erodes not only home rule power but the ability to implement local legislation to meet the Town's Zero Waste initiatives that are in place to protect the Town's current and future environment.

The Town Council believes that the oppositions referenced herein are in the best interest of the health, safety, and welfare of all area residents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF SOUTHWEST RANCHES, FLORIDA:

Section 1: The recitals above are true and correct and are incorporated herein by reference.

Section 2: The Town Council hereby formally opposes Senate Bill 1822 and House Bill 565, which intends to prohibit local regulation of auxiliary containers and erode Home Rule Power.

Section 4. The Town Clerk is directed to send a copy of this Resolution to the Florida State Senate, the Florida House of Representatives, the Florida League of Cities, and the Broward League of Cities.

Section 5. This Resolution shall be effective immediately upon its adoption.

REGULAR MEETING MINUTES OF THE TOWN COUNCIL Southwest Ranches, Florida

A Regular Meeting of the Town Council of Southwest Ranches was held at 13400 Griffin Road in the Southwest Ranches Council Chambers. The meeting, having been properly noticed, was called to order by Mayor Breitkreuz at 7:04 PM. Attendance was noted by roll call and was followed by the Pledge of Allegiance.

Presentations

3. Proclamation – 2025 Arbor Day Proclamation

The Town presented a proclamation recognizing the third Friday in January as Arbor Day in the Town of Southwest Ranches.

4. Public Comment

The following members of the public addressed the Town Council: The Sikh Youth Association, Anna Poniecka, Lazaro Padron, and Tracy Swait.

5. Board Reports

Harold Gubnitsky spoke on behalf of the Zero Waste Advisory Board. He talked about the February 7th meeting and the topics of the meeting such as the development of the scope of work for the zero-waste consultant RFP. He discussed the mission statement of the Board and ideas on how to raise awareness and education such as site visits to the Reuter Recycling Center and spoke about working with the Zero Waste Task Force. He thanked the Town Council for their support with the zero-waste efforts.

6. Council Member Comments

Council Member Jablonski spoke about upcoming events around the Town, such as the Fun Horse Show on February 15th, the DMV FLOW event on February 28th, Water Matters Day on March 8th, the Town's 25th Anniversary event on June 7th, and the Car Show and ChiliFest on February 22nd. He talked about the Town's 5k scheduled for April 5th at Rolling Oaks Park, the Broward County Property Appraiser's Office being at Town Hall the first Tuesday of each month, the Barn Dance on Marth 15th, the Rancher Academy on March 12th and 19th, and Bingo at the Barn on March 22nd. He spoke about the passing of Aster Knight, Marie Nix, and Debra Goff Rose and their contributions to the Town. He talked about the work being done by the Town for the bus stop on Dykes Road. He discussed businesses that were purchasing properties and were using them for illegal businesses and the issues it is causing for the Town and the residents.

Vice Mayor Hartmann spoke about Debra Goff Rose, Marie Nix, and Aster Knight, and how their loss would affect the Town. He talked about the upcoming tour of the Reuter Recycling Center on March 30th and described what the tour entails. He stated to contact him if anyone would like to attend the tour. He discussed the Earth Day event hosted by the Broward Sierra Club at the Anne Kolb Nature Center on March 23rd. He spoke about Water Matters Day happening on March 8th, and how residents could receive native plants for attending. He addressed an issue mentioned during Public Comment regarding the horizontal directional drilling being done by FPL. He responded to Council Member Jablonski's comments regarding businesses operating in the Town illegally and that it should be addressed and discussed further.

Council Member Kuczenski discussed the importance of the Town Advisory Boards and the makeup of the Boards. He spoke about Alina Amaral, a resident that requested to become a member of the Rural Public Arts and Design Board and his desire to appoint her as At-Large Member to the Board.

The following motion was made by Vice Mayor Hartmann, seconded by Council Member Kuczenski, and passed by a 5-0 roll call vote. The vote was as follows: Council Members Allbritton, Jablonski, Kuczenski, Vice Mayor Hartmann, and Mayor Breitkreuz voting yes.

MOTION: TO APPOINT ALINA AMARAL TO THE RURAL PUBLIC ARTS AND DESIGN BOARD AS AN AT-LARGE MEMBER.

He spoke about the issue with the directional boring being done by FPL. He provided Townwide traffic violation statistics for September 2024 through January 2025. He thanked the Town of Davie Police Department for the great job they are doing with their enforcement. He discussed the dangers of speeding in the Town and talked about the locations where the Speed Radar signs will be placed in Sunshine Ranches. He spoke about the culture and farming lifestyle of the Town. He talked about the passing of Debra Goff Rose, Aster Knight, and Marie Nix, and how it has affected him and the Town.

Council Member Allbritton offered his condolences to the families of Debra Goff Rose, Marie Nix, and Aster Knight and spoke about his experiences with them and how their loss has affected him. He talked about the Zero Waste Task Force and their showing of the movie "Buy Now: The Shopping Conspiracy" at the February 12th meeting. He discussed attending a drone demonstration conducted for the Town of Davie Police and Fire Departments. He spoke about the bus stop on Dykes Road, the dangers the students face at the bus stop, and that the Town is working on methods to protect the students and slow down traffic in the area. He discussed the Public Safety and Traffic Committee, its mission, and stated that it still needed another member and that if anyone was interested in joining the Board to contact him.

Mayor Breitkreuz addressed an issue mentioned during Public Comment and spoke about the Town's uniqueness and how the Town is trying to preserve its rural lifestyle. He addressed the residents' concerns about the directional boring being done by FPL. He talked about the upcoming

Rancher Academy and the importance of people attending to learn about the Town especially for realtors to attend so they can understand the Town's character and communicate that to potential buyers planning on moving to the Town. He spoke about the Unity in Diversity 5k and the Sikh Youth Association, and how the name Unity in Diversity is fantastic name for the event. He discussed being selected to represent the Town with the Solid Waste Authority of Broward County and that it was a great opportunity to work with them. He stated that the Authority was making great progress but expressed that he fears the Authority may be leaning towards placing an incinerator in the County. He thanked Debbie Green and Harold Gubnitsky and the teams they are working with in regard to their commitment on waste disposal and that the Town is small but has a big influence on the matter because of their efforts. He discussed the City of Miramar's presentation from the last Town Council Meeting that the legislation the City is attempting to get passed regarding incinerators should be the Town's priority as well. He spoke about Debra Goff Rose, Marie Nix, and Aster Knight and the legacy the have left in the Town. He addressed an issue mentioned in Public Comment regarding the Southwest Ranches Community Farmer's Market. He discussed the intent of having the Farmer's Market, how it has grown and improved, and the improvements being done at the Southwest Meadows Sanctuary.

7. Legal Comments

Town Attorney Poliakoff offered his thoughts and prayers to the families of Debra Goff Rose, Marie Nix, and shared stories of Aster Knight.

8. Administration Comments

Town Administrator Muñiz spoke about Debra Goff Rose, Marie Nix, and Aster Knight and their families and stated it was glad to have the opportunity to have known them. He spoke about the Town's contract with Tower Pest control for pest control services for the Town and that it was not formally brought before the Town Council because the threshold was not over the amount needed for Town Council approval. He stated that there was no provision in the current agreement that allowed the Administration to extend the contract and Council approval was needed.

The following motion was made by Council Member Jablonski, seconded by Vice Mayor Hartmann, and passed by a 5-0 roll call vote. The vote was as follows: Council Members Allbritton, Jablonski, Kuczenski, Vice Mayor Hartmann, and Mayor Breitkreuz voting yes.

MOTION: TO EXTEND TOWER PEST CONTROL'S CURRENT CONTRACT WITH THE SAME TERMS AND CONDITIONS AND AUTHORIZING THE TOWN ADMINISTRATOR TO AUTHORIZE ANY FUTURE EXTENSIONS OF THE CONTRACT.

He advised Town Council that the Household Hazard Waste event scheduled for April 12 would need to be rescheduled and the Town is aiming for the first weekend of May and would inform the Council once it has been confirmed. Additionally, the updated date will be shared on the Town's website and social media platforms. He discussed the Rancher Academy and stated applications are available on the Town website and that it was limited to the first 30 applicants. He spoke about Town of Davie's Civilian Police Academy beginning on March 4th, that it was an 8

week course, it was open to all Town residents, and the fee was \$25. He stated Mayor Breitkreuz had attended a prior academy, and that he and Council Member Jablonski would be attending the upcoming academy. He addressed the issue with FPL underground boring and said there were two different types of boring the company could do and that he would try to have the FPL representative attend a future Town Council meeting to address the concerns of the Town Council
